Congratulations and thank you for your purchase of low maintenance, high quality **CedarWay®** siding by Fortis Plastics (Fortis).

**Terms**

Fortis warrants to the original homeowner/purchaser that for a Limited Lifetime **CedarWay®** siding will be free from manufacturing defects when property installed and subjected to normal use. At Fortis' sole option, we will repair, replace, refinish or refund to you the value of defective siding, but not to exceed the purchase price of the originally installed siding.

In the unlikely event of a claim on your new Fortis **CedarWay®** siding, the warranty on the coated, repaired or replaced siding will continue for the balance of the warranty period for the original siding.

**Protection Schedule/ Original Owner**

**Transferability**

If there is a change in ownership, this warranty may be transferred by the original purchaser of the **CedarWay®** siding to the new owner. The warranty will resume at the same warranty level from the original purchase date to the transfer of ownership to the new owner. There is no warranty transfer beyond the one time transfer from the original purchaser to the new owner. Registration by the second owner must be completed within 30 days of the transfer of property ownership.

## Limitations

**This warranty does not provide protection against any damage, failure or defect caused** by events and situations beyond normal exposure condition, including but not limited to:

- Abuse, neglect or misuse;
- Impact of foreign objects, hail, lightning, fire, flood, hurricane, tornado or any other act of God;
- Improper installation or installation not in strict compliance with procedures outlined in the instruction manual;
- Use of accessories not specifically approved for fastening or receiving Fortis *CedarWay*® siding;
- Improper handling or storage;
- Defects in, failure of, or damage to the wall, material or building on which the *CedarWay*® material was installed;
- Distortion, movement, cracking or settling of the wall, material or the foundation of the building on which the *CedarWay*® material was installed;
- Any cause not directly a result of manufacturing defects.
- Failure to adhere to the specified “Registration & Care Guide”

Fortis *CedarWay*® siding is not warranted against damage caused by mildew, air pollution, exposure to harmful chemicals/cleaners, or normal weathering from the elements. Normal weathering is defined as prolonged exposure to sunlight, atmosphere, and extremes of weather. These elements will gradually cause most colored surfaces to fade, chalk, stain and accumulate dirt. Geographic location, air quality and other factors beyond our control will govern the severity of these conditions. Normal weathering will be determined by criteria set forth by Fortis.

Fortis *CedarWay*® siding also warrants to the original purchaser that for (10) years Cedarway Premium Series siding will not excessively fade, when caused by a manufacturing defect. “Excessive fading” is more than normal weathering from the elements or from air pollution, and which would exceed a Delta E of (4) Hunter units, as determined by Cedarway. At Fortis Cedarway sole option, we will repair, replace, refinish or refund to the original purchaser the value of the siding, not to exceed the purchase price of the originally installed siding.

This warranty is void if the siding has been painted, varnished or otherwise coated over the original manufacturer’s finish.

Fortis reserves the right to discontinue or modify any of its products, including color, without notice to the consumer. Fortis shall not be liable for variations in color or gloss of its product as compared to product that has experiences normal weathering. In the event that the product line is discontinued or modified, Fortis reserves the right to

substitute a product designated to be a comparable price or quality. All claims must be brought to Fortis within 30 days of discovery, but in no event later than 30 days after the years stated in the Protection Schedule.

### Conditions

**This warranty supersedes all other warranties liabilities and obligations, whether oral, written or implied. Fortis specifically disclaims, and purchaser hereby waives, any other representations and warranties, including without limitation warranties of merchantability or fitness for a particular purpose, and warranties arising from course of dealing or usage or trade. Fortis shall not be held liable for damages of any kind, whether punitive, incidental, special, liquidated, consequential or otherwise, including damage to the building structure, its contents or any persons therein resulting from breach of this warranty. Fortis prohibits its distributors, dealers, or representatives from changing the terms of this warranty in any way. Limitations on or exclusion of incidental or consequential damages may be prohibited by law in some states and may not apply to you. This warranty gives the consumer specific legal rights. You may have other rights that vary from state to state.**

### Claims

The consumer is responsible for providing Fortis prompt written notification of any manufacturing defect. The consumer must provide proof of date of purchase and installation with proof of property ownership. All notifications should be sent to Fortis Plastics, 390 Community Drive, Henderson, KY 42420, and Attn: Warranty Services. The claimant may be required to submit a sample of the defective materials for analysis. All potential warranty claims must be *inspected* by an independent licensed siding contractor other than the original installer and/or homeowner at the expense of Cedarway. The assigned *inspection* contractor will make the determination to approve or deny moving forward with standard warranty procedures outlined in this document. Fortis will analyze the material claimed to be defective and determine the validity of the claim. If said material is determined to be defective or otherwise covered as specified under terms of this warranty, Fortis will, within a reasonable amount of time, coat, repair, or replace the siding or refund the amount paid by the original owner for the siding accessories.

### For Your Protection

Your Fortis *CedarWay*® siding is very durable and requires little maintenance. It is, however, made of polypropylene, which is a combustible material. Therefore, common sense should be used to keep your siding from melting or burning. Always keep sources of heat and flames, such as barbeque grills, and combustible materials, such as dry leaves and trash, away from Fortis *CedarWay*® siding.

This Warranty is Effective October 2009 and replaces all prior Warranties.
